Program Expectations, Guidelines & Disciplinary Procedures

Participant Expectations

1. **Respect Others:** Respect the rights of others and exercise self-discipline.
2. **Positive Attitude:** Maintain a positive and cooperative attitude.
3. **Follow Instructions:** Listen to and follow the instructions given by program leaders.
4. **Responsibility:** Take responsibility for your actions and belongings.
5. **Open-Mindedness:** Be open to new experiences and perspectives.
6. **Safety First:** Follow all safety rules and guidelines.
7. **Teamwork:** Work collaboratively with others.
8. **Honesty:** Be honest in your interactions and actions.
9. **Cleanliness:** Keep personal and communal spaces clean and tidy.
10. **Respect Property:** Respect the property of the program and others.
11. **No Bullying:** Refrain from any form of bullying or harassment.
12. **Inclusivity:** Include and respect everyone, regardless of differences.
13. **Ask for Help:** Seek help from staff if needed.
14. **Respect Privacy:** Respect the privacy of others.
15. **Communication:** Communicate any issues or concerns to staff.
16. **Have Fun:** Engage fully and enjoy the program.

Program Guidelines

1. **BSD Rules:** Follow the Bethel School District Student Responsibilities & Rules. Items and conduct that are not allowed at school are NOT allowed at the Teen Summer Nights program
2. **Bathrooms:** No more than 3 students are allowed in the bathroom at the same time. No hanging out in the bathroom.
3. **Campus:** Once a student leaves the program and/or school grounds they are not allowed to return.
4. **Participants:** Only BSD students and approved participants may attend the program. All participants must be registered prior to attending the program.
5. **No backpacks, just small purses allowed or clear bags.**
6. **No taking pictures or video recording, or will be banned from the program.**
7. **No outside food or drink, only empty bottles allowed.**

Disciplinary Procedures

Once an alleged violation is reported to staff, the following procedures will take place:

1. Campus security/staff will conduct an investigation into the alleged violation and verify details of the allegation, including interviewing the person or persons who have made the report, as well as any witnesses who may have observed the incident and report findings to the Program Manager.
2. Campus security & the Program Manager will determine if disciplinary action should be taken based on the findings of the investigation, the nature and severity of the offense, and on whether this represents a repeat offense.
3. If a participant is found in violation of the Participant Expectations, they will be subject to disciplinary action, including but not limited to the following penalties in any order or combination:
